2024 Tax Impacts of Warrant Articles

The DRA's formula for figuring what the impact of a warrant article is generally referred as the "Three-Finger Rule". Using the current assessed property value of the town from the MS-1 (\$370,653,184 in 2023), covering the last three digits would approximately equal \$1.00 on the tax rate, covering the next digit would equal .10 and the next would equal .01.
