SECOND SESSION

The second session will be held at the Canterbury Elementary School on Friday the Fourteenth of March 2025 at seven o'clock to act on the following subjects.

4. To see if the Town will vote to raise and appropriate the sum of Three-Million, Four-Hundred and Sixty-Nine Thousand, Nine-Hundred and Fifty-Eight Dollars (\$3,469,958) for general municipal operations. This article does not include appropriations contained in special or individual articles addressed separately. (*Majority Vote Required.*) *Recommended by the Selectmen.*

5. To see if the Town will vote to raise and appropriate the sum of Eighty-Eight Thousand Dollars (\$88,000) to be deposited into the following Capital Reserves:

(Majority Vote Required.) Recommended by the Selectmen.		

6. To see if the Town will vote to raise and appropriate the sum of Thirty-Five Thousand Eight-Hundred and Seventy-Four dollars (\$35,874) to pay principal (\$35,000) and interest (\$874) on the Gold Star Bond, said amount to be removed from the Town's Unassigned Fund Balance. (*Majority Vote Required.*) *Recommended by the Selectmen.*

7. To see if the Town will vote to raise and appropriate the sum of Seven-Thousand Dollars (\$7,000) for the purchase of a ballot counting device. (*Majority Vote Required.*) *Recommended by the Selectmen.*

8. To see if the Town will vote to raise and appropriate the sum of Eighty-Thousand (\$80,000) for the renovation of the Sam Lake House (Town Office) Garage and to withdraw the funds from the Capital Reserve Account created for this purpose. (*Majority Vote Required.*) *Recommended by the Selectmen.*

9. To see if the Town will vote to raise and appropriate the sum of Twenty-Thousand Dollars (\$20,000) for the purpose of "Weatherization" of the Elkins Public library. *(Majority Vote Required.) Recommended by the Selectmen.*

10. To see if the Town will vote to raise and appropriate the sum of Sixty-Thousand Dollars (\$60,000) to replace the existing packer truck with a stationary electric compactor with VFD, a compaction container, and the installation of a concrete pad. (*By Petition, Majority Vote Required.*) *Not Recommended by the Selectmen.*

11. To see if the Town will vote to establish a Capitol Reserve Account for the purpose of purchasing voting equipment, and to appoint the Board of Selectmen agents to expend such funds, and to deposit the sum of Five-Thousand Dollars (\$5,000) into said fund. (*Majority Vote Required.*) *Recommended by the Selectmen.*

12. To see if the Town will vote to establish a Renewable Energy Capital Reserve Fund under the provisions of RSA 35:1 for the purchase of renewable energy systems and to raise and appropriate the sum of Two-Thousand dollars (\$2,000) to be placed in said fund from Community Power discretionary adder funds. Additional funds would come from the same Community Power adder funds and doesn't require any tax funding. Further, to name the Select Board as agents to expend from said fund. *(Majority Vote Required.) Recommended by the Selectmen.*

13. To see if the town will raise and appropriate the sum of Two-Hundred and Fifty (\$250,000) for the purpose of installing additional solar panels and battery storage at the Canterbury Municipal Complex and to further authorize the issuance of bonds or notes in accordance of the municipal finance act (RSA 33) and to further authorize the municipal officials to issue and negotiate such bonds or notes and the interest rate. This appropriation would foster the Town's "Plan for Tomorrow" goal of having all town buildings on renewable energy by 2035. (*Majority Vote Required.*) *Recommended by the Selectmen*.

14. To see if the Town will authorize the Selectmen to accept up to Fifteen-Thousand Dollars (\$15,000) from the forced distribution of funds from the Sam Lake Trust Fund. The exact dollar amount is to be determined by the Trustees of the Sam Lake Trust Fund and distributed to the Town by the end of the calendar year. (*Majority Vote Required.*) *Recommended by the Selectmen.*

15. To see if the Town will raise and appropriate the sum of Ten-Thousand Dollars (\$10,000) for the purpose of holding a House Hold Hazardous Waste Day at the Canterbury Transfer Station. *Majority Vote Required, Recommended by the Selectmen*

To transact any other business that may legally come before this meeting.
